### 2020 WESTGATE LAS VEGAS SUPERCONTEST RULES AND REGULATIONS

The "Westgate Las Vegas 2020 SuperContest" (hereinafter the "SuperContest", "Contest" or "Promotion") refers to the events commencing Monday, January 13, 2020 at 9:00 AM. and ending on Sunday, January 3, 2021 (pending no games are in delay per rule 22). ("Promotional Period") at the Westgate Las Vegas Resort & Casino ("Sponsor") located at 3000 Paradise Road, Las Vegas, Nevada 89109. All references to time of day contained herein refer to Las Vegas, Nevada time.

1. All contestants and proxies must be at least 21 years of age to participate. Contestants must provide valid proof of age that is acceptable to Westgate Las Vegas Resort & Casino (driver's license, current passport, or state identification card), which may act in its sole and absolute discretion as it deems appropriate. If contestant is not a U.S. resident, a current passport or alien registration card is required.
2. All contestants must have a Westgate Las Vegas Resort & Casino WOW rewards card. Westgate Las Vegas Resort & Casino WOW cards are free and are available at the WOW Rewards Center and/or the SuperBook.
3. Contestants can participate in the Westgate Las Vegas SuperContest by paying a fee of \$1,500 per entry. Entry fees are valid all season and are non-refundable. Method of payment includes cash, cashier's check, money order, Westgate Las Vegas Resort & Casino live gaming chips and credit card. No personal checks will be accepted. All cashier's checks and money orders must be made out to Westgate Las Vegas Resort & Casino. Debit/Credit cards are subject to a 3% surcharge.
4. Entry fees will begin being accepted for the Westgate Las Vegas SuperContest at 9:00 AM on Monday, January 13, 2020 and conclude at 3:00 PM Saturday, September 12, 2020.
5. Maximum of three (3) entries per contestant. Each entry shall be treated as a separate entry for all purposes, including prize distribution. The Westgate Las Vegas SuperBook reserves the right to approve all aliases (limited to 20 characters/no commas). Westgate management has the right to change any alias name for any reason. Entering the SuperContest does not preclude a contestant from entering the SuperContest Gold or SuperContest Reboot.
6. The Westgate Las Vegas SuperContest will begin Wednesday, September 9, 2020 and conclude on Sunday, January 3, 2021 (provided no games are in delay per rule 22).
7. The Westgate Las Vegas SuperContest is based on selecting winning teams against the Westgate Las Vegas SuperBook contest line. Contestants must select five (5) professional football teams per entry, per week. Contestants may not select both sides of the same game on a single entry. In the event a contestant has multiple entries they may select one side of the game on one (1) entry and the opposite side of the same game on any other entry.
8. Contest winners will be determined by the total number of points accumulated during the professional football regular season. Each winning selection against the contest line will count as one (1) point. Ties (pushes) against the contest line count as one half (1/2) point.
9. Weekly selection card will be available at approximately 5:00 PM each Wednesday during the promotional period. Contestant weekly selections will be available in the Westgate Las Vegas SuperBook as early as close of business Saturday and as late as 8:00 AM Sunday mornings (this is tentative and may change prior to the start of the season). Current standings will be available in the Westgate Las Vegas SuperBook each Tuesday afternoon. Current standings and selections may be available on [WestgateVegas.com](http://WestgateVegas.com) for information purposes only. Westgate Las Vegas SuperBook shall not be responsible for any errors and/or misinformation on its website. Official standings and selections are only available in the Westgate Las Vegas SuperBook.
10. Each contestant may authorize a proxy to submit their weekly selections by properly signing and authorizing such. Both contestant and proxy must sign-up, in person, at the same time in the Westgate Las Vegas SuperBook. The Westgate Las Vegas SuperBook is not responsible for any contestant being unable to submit his/her picks for any reason. It is the responsibility of each contestant to reach an understanding with his/her proxy service for a contingency plan on submitting picks in the event that any issues arise. Westgate Las Vegas SuperBook does not endorse or recommend any proxy or proxy service and shall not be involved in any proxy agreement under any circumstance. Furthermore, all contestants assume sole liability of submitting their weekly selections. Westgate Las Vegas SuperBook will under no circumstances mediate between any contestant and any proxy.
11. Contestants/proxies will be required to swipe their Westgate Las Vegas SuperContest ID card at the Westgate Las Vegas SuperBook self-service contest window to make their selections. By signing the official entry form, the entrant becomes the "official contestant" and is the only one approved to collect any prize monies. Proxies are not eligible to collect any prize monies. Contestants may share winnings by filling out IRS Form 5754 (Statement by Person(s) Receiving Gambling Winnings) once the Westgate Las Vegas SuperContest winners become official. Prize money must be collected within 365 days of contest becoming official. To replace any lost Westgate Las Vegas SuperContest ID card there will be a \$5 service charge.
12. Contestants must submit their weekly selections at the Westgate Las Vegas SuperBook between each Wednesday when contest lines are available (approx. 5:00 PM) and 11:00 PM each Saturday. Mobile selection deadline is 6:00 PM each Saturday. In the event a contestant wishes to use any game that starts before this 11:00 PM Saturday deadline their weekly selections must be submitted prior to the start of those games. Contestant(s) who fail to submit their weekly selection by 11:00 PM every Saturday will be awarded zero (0) points that week. **THIS TIME DEADLINE IS STRICTLY ENFORCED.**
13. The 2020 Westgate SuperContest contestants can submit their weekly selections via the SuperContest mobile app. Mobile selections must be submitted during each week of the 2020 NFL regular season by Saturday at 6:00 PM pacific time via the SuperContest mobile app. Contestants/Proxies must be within the approved geographic boundary to make mobile selections. The Westgate SuperBook is not responsible for any technical difficulties, malfunctions or any predictable or unforeseen issues regardless of whether the issues are on the end of the SuperContest app or the contestant/proxy. Each contestant is therefore responsible for submitting his/her picks over the counter before the 11:00 PM Saturday deadline in the event that they are unable to do so via the mobile app.
14. The selection ticket (receipt) generated by the Westgate Las Vegas SuperBook computer system is the official weekly entry of record. The contestant's official selections will be those contained in the Westgate Las Vegas SuperBook computer system records. If a selection ticket is not produced via the self-service contest window the contestant/proxy must notify a Westgate Las Vegas SuperBook Supervisor immediately to receive a printed copy of their weekly selections. The "selection sheet" itself is not an official entry of record.
15. Weekly selections are only submitted once per contest entry. Contestants/proxies cannot void weekly selections after the Westgate SuperBook business day they are submitted. Weekly Westgate Las Vegas SuperContest selection ticket void requests must be submitted to a Westgate Las Vegas SuperBook Supervisor for approval. In the event a contestant has multiple entries; a contestant/proxy must submit separate weekly selections for each entry. If more than one (1) weekly selection is erroneously accepted for an entry, the first entry of weekly selections associated with that entry will be the official selections of record.
16. Westgate Las Vegas SuperContest Prize Structure

**All percentages based on entry fees.** Prize pool consists of all entry fees less \$120 per entry for administrative fees and split Bonus prize monies. Tie-breaking rules will be applied to determine the first place only. Contestants tying for second (2nd) through one hundredth (100th) place will equally split aggregate prize money for the respective place. In the event of a first-place tie, the first-place prize winner will be determined based on the contestant that accumulated the most contest points during the final three (3) weeks of the regular season. If total points accumulated during the final three (3) weeks are equal then the tie-breaker will revert to Week 14, then Week 13, then Week 12, etc. to determine the first place prize winner. In the event of a tie after all weekly tie-breakers, dual first place winners will be declared, and the aggregate prize money will be split equally amongst the number of contestants still tied for first place.

The SuperContest pays out four (4) \$135,000 in-season Quarter Bonus cash awards to the contestant (s) that accumulate the most points during the time frame of the respective quarterly contest.

1st Quarter Bonus	Weeks 1 - 4
2nd Quarter Bonus	Weeks 5 - 8
3rd Quarter Bonus	Weeks 9 - 12
4th Quarter Bonus	Weeks 13 - 16

Quarter Bonus payouts will be on the following schedule: \$100,000 will go to first (1st) place, \$25,000 will go to second (2nd) place and \$10,000 will go to third (3rd) place. Contestants tying for Quarter Bonus places will equally split aggregate prize money for the respective place. The total in-season Quarter Bonus prize pool is \$540,000 comprised of \$440,000 from the SuperContest entry fee final winners prize pool and \$100,000 provided by the Westgate Las Vegas SuperBook. Each Quarter Bonus consists of four (4) weeks and must consist of said weeks to be official. Any disputes must be made in writing to management during the three (3) day verification period for all in-season Quarter Bonus awards. The Quarter Bonus awards will be declared official at the end of the three day verification period for each respective Quarter Bonus.

17. The professional football regular season must consist of at least ten (10) weeks for the Westgate Las Vegas SuperContest to be considered valid. If the regular season is shortened to less than ten (10) weeks, the Westgate Las Vegas SuperContest will be cancelled and all entry fees will be refunded. This does not apply to the 1st and 2nd Quarter Bonuses.
18. **ALL WESTGATE LAS VEGAS SUPERBOOK HOUSE RULES APPLY TO THIS CONTEST UNLESS OTHERWISE STIPULATED IN THESE RULES.**
19. The Westgate Las Vegas SuperBook reserves the right to cancel this contest or refuse to accept any registration or wager if the same could violate any federal, state or county law, ordinance or regulation. Furthermore, the Westgate Las Vegas SuperBook may cancel the contest in the event of technical difficulties or other occurrences beyond the control of the Westgate Las Vegas SuperBook.
20. Selections may be accepted manually in case of a computer system failure or other unforeseen circumstances as deemed necessary by Westgate Las Vegas SuperBook management.
21. Entry fees will not be refunded for reasons other than the cancellation of the Westgate Las Vegas SuperContest.
22. For contest purposes, all games are action despite a location change. In the event of a game cancellation or postponement, the game must be played by Tuesday of the following week to be applied toward contest standings or contestant will be awarded zero points for that game.
23. After the final winners are posted on Monday, January 4, 2021, a three (3) day verification period will occur. Any disputes with the contest and results or prize allocation must be provided to management in writing within this verification period. At the end of the three (3) day verification period, the Westgate Las Vegas SuperContest results will be declared official and payout will be awarded Friday, January 8, 2021. In the event of a dispute, the decision of management is final.
24. Employees as well as family and household members of Westgate Las Vegas Resort and Casino employees may not participate or serve as a proxy in the Westgate Las Vegas SuperContest.
25. All contestants agree to grant Westgate Las Vegas Resort & Casino unconditional use of their name and likeness for promotion as/advertising and announcements without compensation, consideration, notice review or consent.
26. All decisions regarding the interpretation of rules, eligibility, etc. for this promotion lie solely with Westgate Las Vegas Resort & Casino whose decisions are final.
27. All contest times are approximate. Westgate Las Vegas Resort & Casino reserves, in full, all rights in enforcing any time deadlines and Westgate Las Vegas Resort & Casino's decision will be final.
28. All entries are subject to review and verification.
29. Westgate Las Vegas Resort & Casino reserves the right to modify or cancel this contest at any time for any reason, subject to any applicable regulatory approval provided that such modification shall not, as the date of such modification, materially alter or change any participant's prize already awarded.
30. Westgate Las Vegas Resort & Casino may disqualify any person for any prize based upon Westgate Las Vegas Resort & Casino's belief of the possible commission of fraud, dishonest, violation of contest rules or other misconduct whether or not related to this contest.
31. Record of entries will be retained for record keeping purposes in accordance with legal requirements.
