



2026-27 SUPERCONTEST RULES AND REGULATIONS

The "2026 SuperContest" (hereinafter the "SuperContest", "Contest" or "Promotion") refers to the events commencing Wednesday, July 1, 2026, at 9:00AM, and ending on Sunday, January 10, 2027 (pending no games are in delay per rule 22). ("Promotional Period") at the Westgate Las Vegas Resort & Casino or "The SuperBook" ("Sponsor") located at 3000 Paradise Road, Las Vegas, Nevada 89109. All references to time of day contained herein refer to Las Vegas, Nevada time.

- 1. All contestants and proxies must be at least 21 years of age to participate. Contestants must provide valid proof of age that is acceptable to The SuperBook (driver's license, current passport, or state identification card), which may act in its sole and absolute discretion as it deems appropriate. If contestant is not a U.S. resident, a current passport or alien registration card is required.
- 2. All contestants must have a Westgate Las Vegas Resort & Casino WOW rewards card. Westgate Las Vegas Resort & Casino WOW cards are free and are available at the WOW Rewards Center or the casino cage.
- 3. Contestants can participate in the SuperContest by paying a fee of \$1,500 per entry. Entry fees are valid the entire regular season (weeks 1-18) and are non-refundable. Method of payment includes cash, cashier's check, money order, Westgate Las Vegas Resort & Casino live gaming chips and credit card. No personal checks will be accepted. All cashier's checks and money orders must be made out to Westgate Las Vegas Resort & Casino. Debit/Credit cards are subject to a 3% surcharge.
- 4. Entry fees will begin being accepted for the SuperContest at 9:00 AM on Wednesday, July 1, 2026, and conclude at 3:00 PM on Saturday, September 12, 2026.
- 5. Maximum of ten (10) entries per contestant. Each entry shall be treated as a separate entry for all purposes, including prize distribution. The SuperBook reserves the right to approve all aliases (limited to 20 characters/no commas). Management has the right to change any alias name for any reason. Entering the SuperContest does not preclude a contestant from entering any other contest.
- 6. The SuperContest will begin Tuesday, September 8, 2026, and conclude Sunday, January 10, 2027 (provided no games are in delay per rule 22).
- 7. The SuperContest is based on selecting winning teams against The SuperBook contest line. Contestants must select five (5) professional football teams per entry, per week. Contestants may not select both sides of the same game on a single entry. In the event a contestant has multiple entries they may select one side of the game on one (1) entry and the opposite side of the same game on any other entry.
- 8. Contest winners will be determined by the total number of points accumulated during the professional football regular season. Each winning selection against the point spread will count as one (1) point. Ties (pushes) against the point spread count as one half (1/2) point. In the event of an NFL team forfeiting a game, the winning team will be awarded one (1) point and the forfeiting team will be awarded zero (0) points. This rule does NOT apply to games that are canceled and/or postponed.
- 9. Weekly selection sheets will be available at approximately 5:00 PM each Wednesday (Tuesday for Week 1) during the promotional period. Contestant weekly selections will be available in The SuperBook on Saturday evening. Current standings will be available in the SuperBook each Tuesday afternoon (provided no games are in delay per rule 22). Current standings and selections may be available on WestgateLasVegas.com for information purposes only. The SuperBook shall not be responsible for any errors and/or misinformation on its website. Official standings and selections are only available in The SuperBook.
- 10. Each contestant may authorize a proxy to submit their weekly selections by properly signing and authorizing such. Both contestant and proxy must sign-up, in person, at The SuperBook or designated signup area. The SuperBook is not responsible for any contestant being unable to submit his/her picks for any reason. It is the responsibility of each contestant to reach an understanding with his/her proxy service for a contingency plan on submitting picks if any issues arise.
- 11. Contestants/proxies will be required to swipe their SuperBook Contest ID card at the SuperBook self-service contest window to make their selections. By signing the official entry form, the entrant becomes the "official contestant" and is the only one approved to collect any prize monies. Proxies are not eligible to collect any prize monies. Contestants may share winnings by filling out IRS Form 5754 (Statement by Person(s) Receiving Gambling Winnings) once the SuperContest winners become official. Prize money must be collected within 90 days of contest becoming official.
- 12. **Contestants must submit their weekly selections at The SuperBook between each Wednesday (Tuesday Week 1) when contest lines are available (approx. 5:00 PM) and 5:00 PM each Saturday. In the event a contestant wishes to use any game that starts before this 5:00 PM Saturday deadline their weekly selections must be submitted prior to the start of those games. Contestant(s) who fail to submit their weekly selection by 5:00 PM every Saturday will be awarded zero (0) points that week. DEADLINE IS STRICTLY ENFORCED.**
- 13. The 2026 SuperContest contestants can submit their weekly selections via the SuperContest mobile app. Mobile selections must be submitted during each week of the 2026 NFL regular season by Saturday at 5:00 PM pacific time via the SuperContest mobile app. Contestants/Proxies must be within the approved geographic boundary to make mobile selections. The SuperBook is not responsible for any technical difficulties, malfunctions or any predictable or unforeseen issues regardless of whether the issues are on the end of the SuperContest app or the contestant/proxy. Each contestant is therefore responsible for submitting his/her picks over the counter before the 5:00 PM Saturday deadline if they are unable to do so via the mobile app. Receipts on the SuperContest contest app will be in the form of a digital confirmation screen (complete with unique identifying confirmation code which is a 12-digit electronic ticket serial number) reflecting selections made, and such receipts represent the official entry of record for the entrant's weekly selections. Entrants are encouraged to screenshot the confirmation screen when it appears just after selection submission through the app which will have the 12-digit ETSN number. No other documents provided to the SuperBook shall be considered official record of weekly selections.
- 14. The selection ticket (receipt) generated by The SuperBook computer system is the official weekly entry of record. The contestant's official selections will be those contained in The SuperBook computer system records. If a selection ticket is not produced via the self-service contest window the contestant/proxy must notify a SuperBook Supervisor immediately to receive a printed copy of their weekly selections. The "selection sheet" itself is not an official entry of record.
- 15. Weekly selections are only submitted once per contest entry. Contestants/proxies cannot void weekly selections after The SuperBook retail counter closes on the day they are submitted. Weekly SuperContest selection ticket void requests must be submitted to a SuperBook Supervisor for approval. In the event a contestant has multiple entries; a contestant/proxy must submit separate weekly selections for each entry. If more than one (1) weekly selection is erroneously accepted for an entry, the first entry of weekly selections associated with that entry will be the official selection of record.

16. SuperContest Prize Structure

All percentages based on entry fees. Prize pool consists of all entry fees less split Bonus prize monies.

Tie-breaking rules will be applied to determine the overall first place only. Contestants tying for second (2nd) through twentieth (20th) place will equally split aggregate prize money for the respective place. In the event of a first-place tie, the first-place prize winner will be determined based on the contestant that accumulated the most contest points during the final three (3) weeks of the regular season. If total points accumulated during the final three (3) weeks are equal then the tiebreaker will revert to Week 15, then Week 14, etc. to determine the first-place prize winner. In the event of a tie after all weekly tiebreakers, dual first place winners will be declared, and the aggregate prize money will be split equally amongst the number of contestants still tied for first place.

The SuperContest will pay out two (2) NINE WEEK Contests, three (3) SIX WEEK Contests and six (6) THREE WEEK Contests for in-season Bonus cash awards to the contestant(s) that accumulate the most points during the time frame for the respective contest.

The In-Season Bonus weeks and awards are as follows:

In-Season Bonus payouts will be on the following schedule; for the **nine (9) week contest** \$50,000 will go to first (1st) place, \$30,000 will go to second (2nd) place, \$20,000 will go to third (3rd) place, \$10,000 will go to fourth (4th) place, and \$5,000 will go to fifth (5th) place. In-Season Bonus payouts will be on the following schedule for the **six (6) week contest**: \$25,000 will go to first (1st) place, \$15,000 will go to second (2nd) place, \$10,000 will go to third (3rd) place, and \$5,000 will go to fourth (4th) place. In-Season Bonus payouts will be on the following schedule for the **three (3) week contest**: \$15,000 will go to first (1st) place, \$10,000 will go to second (2nd) place and \$5,000 will go to third (3rd) place. Contestants tying for In-Season Bonus places will equally split aggregate prize money for the respective place. The total in-season prize pool is \$575,000 comprised from SuperContest entry fee final winner's prize pool. Each In-Season Bonus consists of specific weeks and must consist of said weeks to be official. Any disputes must be made in writing to management during the three (3) day verification period for all In-Season Bonus awards. The In-Season Bonus awards will be declared official at the end of the three (3) day verification period for each In-Season Bonus.

- 17. The professional football regular season must consist of nine (9) weeks for the SuperContest to be considered valid. In the event of cancellation before nine (9) complete weeks, prorated entry fees will be refunded. This prorated dollar amount is to reflect in-season prizes previously awarded. In the event of cancellation after nine (9) weeks, unfinished in-season prize money will be diverted to the final prize pool.
- 18. All SuperBook House Rules apply to this contest unless otherwise stipulated in these rules.
- 19. The SuperBook reserves the right to cancel this contest or refuse to accept any registration or wager if the same could violate any federal, state or county law, ordinance, or regulation. Furthermore, The SuperBook may cancel the contest in the event of technical difficulties or other occurrences beyond the control of the SuperBook.
- 20. Selections may be accepted manually over the counter in case of a computer system failure or other unforeseen circumstances as deemed necessary by SuperBook management.
- 21. Entry fees will not be refunded for reasons other than the cancellation of the SuperContest.
- 22. For contest purposes, all games are action despite a location change. In the event of a game cancellation or postponement, the game must be played by Tuesday at 11:59 PM of the current week to be applied toward contest standings or contestant will be awarded .5 (1/2) point for that game if selected.
- 23. After the final winners are posted, a three (3) day verification period will occur. Any disputes with the contest and results or prize allocation must be provided to management in writing within this verification period. At the end of the three (3) day verification period, the SuperContest results will be declared official, and payout will be awarded on Friday, January 15, 2027. Payouts can be transferred into a contestants Mobile Wagering Account by providing SuperBook management proper documentation. In the event of a dispute, the decision of management is final.
- 24. Key employees, as well as family members of the SuperBook, may not participate or serve as a proxy in the SuperContest.
- 25. All contestants agree to grant The SuperBook unconditional use of their name and likeness for promotion as/advertising and announcements without compensation, consideration, notice review or consent.
- 26. All decisions regarding the interpretation of rules, eligibility, etc. for this promotion lie solely with The SuperBook whose decisions are final.
- 27. All contest times are approximate. The SuperBook reserves, in full, all rights in enforcing any time deadlines and all decisions will be final.
- 28. All entries are subject to review and verification.
- 29. The SuperBook reserves the right to modify or cancel this contest at any time for any reason, subject to any applicable regulatory approval provided that such modification shall not, as the date of such modification, materially alter or change any participant's prize already awarded.
- 30. The SuperBook may disqualify any person for any prize based upon belief of the possible commission of fraud, dishonest, violation of contest rules or other misconduct whether or not related to this contest.
- 31. Record of entries will be retained for record keeping purposes in accordance with legal requirements.
- 32. Individuals who are excluded from casino facilities, including through a government program, at Westgate Las Vegas Resort & Casino discretion, or by their own request, are not eligible to participate or win any prize.
- 33. A copy of these rules and any changes will be available at the Westgate Las Vegas SuperBook throughout the duration of this contest.
- 34. All laws and regulations of the Nevada State Gaming Commission and Gaming Control Board apply.
