2026-27 SUPERCONTEST SURVIVOR RULES AND REGULATIONS

The "2026-27 SuperContest Survivor" (hereinafter the "SuperContest Survivor", "Survivor," "Contest" or "Promotion") refers to the events commencing Wednesday, July 1, 2026, at 9:00 AM and ending on Sunday, January 10, 2027 (pending no games are in delay per rule 11). (Promotional Period") at the Westgate Las Vegas Resort & Casino ("Sponsor") located at 3000 Paradise Road, Las Vegas, Nevada 89109. All reference to time of day contained herein refer to Las Vegas, Nevada time.

1. All contestants and proxies must be at least 21 years of age to participate. Contestants must provide valid proof of age that is acceptable to The SuperBook (driver's license, current passport, or state identification card), which may act in its sole and absolute discretion as it deems appropriate. If contestant is not a U.S. resident, a current passport or alien registration card is required.
2. All contestants must have a Westgate Las Vegas Resort & Casino WOW rewards card. Westgate Las Vegas Resort & Casino WOW cards are free and are available at the WOW Rewards Center or the casino cage.
3. Contestants can participate in the SuperContest Survivor by paying a fee of \$5,000 per entry. Entry fees are valid the entire regular season (Weeks 1-18) and are non-refundable. Method of payment includes cash, cashier's check, money order, Westgate Las Vegas Resort & Casino live gaming chips and credit card. No personal checks will be accepted. All cashier's checks and money orders must be made out to Westgate Las Vegas Resort & Casino. Debit/Credit cards are subject to a 3% surcharge.
4. Entry fees will begin being accepted for the SuperContest Survivor at 9:00 AM on Wednesday, July 1, 2026, and conclude at 3:00 PM on Saturday, September 12, 2026.
5. Maximum of ten (10) entries per contestant. Each entry shall be treated as a separate entry for all purposes, including prize distribution. The SuperBook reserves the right to approve all aliases (limited to 20 characters/no commas). SuperBook management has the right to change any alias name for any reason. Entering the SuperContest Survivor does **not** preclude a Contestant from entering any other contest. Purchasing more than ten (10) entries will result in disqualification from the Contest without refund. Entrants who have multiple entries earning prizes will be paid for each entry's corresponding prize dollar amount. **HOWEVER**, entrants may purchase up to twenty (20) additional entries before the Saturday, September 12, 2026, 3:00 PM deadline **IF** the entrant's original entry(s) lost on the opening Wednesday Night Football game on September 9, 2026 and/or Thursday Night Football game on September 10, 2026 (examples: if an entrant purchased ten (10) entries and lost all 10 entries on the opening Wednesday Night or Thursday Night Football game, the entrant would have the ability to purchase up to ten (10) additional entries; if an entrant purchased (10) entries and lost five (5) on the opening Wednesday Night or Thursday Night Football game, the entrant would have the ability to purchase up to five (5) additional entries, etc.). A Contestant is allowed to purchase ten (10) entries and submit them all for Wednesday Night Football on September 9, 2026; should the Contestant lose he/she would then have the ability to purchase ten (10) additional (new) entries and submit them all for Thursday Night Football on September 10, 2026 and should the Contestant lose he/she would then have the ability to purchase ten (10) additional (new) entries before the Saturday, September 12, 2026 3:00 PM registration deadline. When repurchasing additional entries, an entrant must show a SuperBook team member their current contest ID card and after verifying how many active entries an entrant has left the SuperBook team member will then sign the entrant up for the new requested number of entries with a different and separate alias from the original entry. An entrant cannot go into Saturday's signup deadline with more than ten (10) active entries otherwise it will result in disqualification from the Contest without refund.
6. Each contestant may authorize a proxy to submit their weekly selections by properly signing and authorizing such. Both contestant and proxy must sign-up, in person, at the same time in the SuperBook or designated signup location. The SuperBook is not responsible for any contestant being unable to submit his/her picks for any reason. It is the responsibility of each contestant to reach an understanding with his/her proxy service for a contingency plan on submitting picks if any issues arise.
7. Contestants/proxies will be required to swipe their SuperBook Contest ID card at The SuperBook self-service contest window to make their selections or via the SuperContest Contest mobile app. Contestants/Proxies must be within the approved geographic boundary to make mobile selections. The SuperBook is not responsible for any technical difficulties, malfunctions or any predictable or unforeseen issues regardless of whether the issues are on the end of the SuperContest Contest app or the contestant/proxy. Each contestant is therefore responsible for submitting his/her picks over the counter before the 5:00 PM Saturday deadline if they are unable to do so via the mobile app. The selection ticket (receipt) generated by the SuperBook computer system is the official weekly entry of record. The contestant's official selections will be those contained in the SuperBook computer system records. If a selection ticket is not produced via the self-service contest window the contestant/proxy must notify a SuperBook Supervisor immediately to receive a printed copy of their weekly selections. The "selection sheet" itself is not an official entry of record. Receipts on the SuperContest contest app will be in the form of a digital confirmation screen (complete with unique identifying confirmation code which is a 12-digit electronic ticket serial number) reflecting selections made, and such receipts represent the official entry of record for the entrant's weekly selections. Entrants are encouraged to screenshot the confirmation screen when it appears just after selection submission through the app which will have the 12-digit ETSN number. No other documents provided to The SuperBook shall be considered official record of weekly selections. The SuperContest contest app geolocation software precludes a contestant who logs in from out of state for the purposes of viewing the contest lines and then subsequently having someone else (i.e. in this case a proxy) re-log in within Nevada to then submit their contest selections for up to thirty (30) minutes. This timeout period for location spoofing will in no way extend the Contest deadline under any circumstances. All Contestants are responsible for anyone who logs into their Contest account during the Contest selection period.
8. **Contestants must submit their weekly selections at the SuperBook between each Wednesday (Tuesday Week 1) when contest lines are available (approx. 5:00 PM) and 5:00 PM each Saturday. In the event a contestant wishes to use any game that starts before this 5:00 PM Saturday deadline their weekly selections must be submitted prior to the start of those games. Contestant(s) who fail to submit their weekly selection by 5:00 PM every Saturday will be eliminated from the contest. DEADLINE IS STRICTLY ENFORCED.** Attempts to make selections after the Contest Week selection deadlines will not be accepted. Before a Contest winner is determined, any entry of the Contest that does not make a selection for a Contest Week prior to that Contest Week's deadline will be eliminated.
9. Weekly selections are only submitted once per contest entry. Contestants/proxies cannot void weekly selections after the SuperBook retail counter closes on the day they are submitted. Weekly SuperContest Survivor selection ticket void requests must be submitted to a SuperBook Supervisor for approval. In the event a contestant has multiple entries; a contestant/proxy must submit separate weekly selections for each entry. If more than one (1) weekly selection is erroneously accepted for an entry, the first entry of weekly selections associated with that entry will be the official selections of record.
10. Entrants with multiple entries may make contradictory selections across their multiple selections. Each entry will be treated as an independent entity for all selections and the determination of prizes.
11. For Contest purposes, all games are "action" despite any change in a game's location. If a game deviates from its originally scheduled time and location, the game must be completed by 1:59 AM on Wednesday of the Contest Week in order for it to be applied towards Contest standings. Games that are not completed within the "Contest Week" will be graded a loss for the Contest and the entry will be eliminated. A "Contest Week" shall mean seven (7) consecutive calendar days starting on Wednesday at 2:00 AM and ending on the following Wednesday at 1:59 AM. If the National Football League ("NFL") awards a win and a loss for a game before the Contest Week ends and without the game being played (as in the case of a forfeit), any selections for the winning team as deemed by the NFL will advance to the next Contest Week. Subsequently, any selections for the losing team as deemed by the NFL will be eliminated from the Contest.
12. By signing the official entry form, the entrant becomes the "official contestant" and is the **only** one approved to collect any prize monies. Proxies are **not** eligible to collect any prize monies. Contestants may share winnings by filling out IRS Form 5754 (Statement by Person(s) Receiving Gambling Winnings) once the SuperContest Survivor winners become official. Prize money must be collected within 90 days of contest becoming official.
13. The Contest is won by being the last remaining entrant with a correct selection during the NFL season. Losing weekly selections will cause an entry to be eliminated from the Contest. Weekly selections will be made on teams to win without the use of a point spread. Entrants may only pick each professional football team one (1) time throughout the duration of the Contest (example: an entrant selects Team A to win during Contest Week 1 of the professional football season. Team A will no longer be available for selection for the duration of the Contest). Weekly selections shall be graded as a loss if the selected team ends their game in a tie. There will be up to eighteen (18) selections made by each entry for this Contest

14. All entrants with an incorrect selection will be eliminated. The Contest proceeds or the Contest Winner(s) is/are then determined as follows:
 - A. If more than one entry remains and at least one Contest Week remains, all remaining entries continue to the next Contest Week.
 - B. If exactly one entry remains, that entry is determined the Contest Winner, regardless of the Contest Week in which this occurs.
 - C. If zero entries remain, the Contest ends and the prize pool will be split equally among all entries that successfully submitted a selection in the Contest Week that is concluding, regardless of the Contest Week in which this occurs.
 - D. If more than one entry remains but no Contest Weeks remain, the Contest will end, and the prize will be split equally among all entries that successfully submitted a selection in the final Contest Week (Week 18).
15. Prize Structure: The Contest prize will consist of all entry fees. SuperContest Survivor Contest Winner(s) will be paid out starting January 15, 2027, regardless of what week the contest concludes/ends. This date will align with the payouts for the end of season prizes for the SuperContest. Any disputes must be made in writing to management during the three (3) day verification/audit period which begins with the conclusion of the NFL regular season. Winnings must be collected within 90 days of conclusion of the contest. Payouts can be transferred into a contestants Mobile Wagering Account by providing SuperBook management proper documentation. If an official Contestant dies during the Survivor contest and is owed any monies from winnings, then pursuant to the executor of the Contestant's estate showing SuperBook management both a death certificate of the Official Contestant and documentation that he/she is the executor of such estate, then at that time The SuperBook will make payment in the form of cash and/or a check to the executor of such estate.
16. The professional football regular season must consist of nine (9) weeks for the SuperContest Survivor to be considered valid. In the event of cancellation before nine (9) complete, all entry fees will be refunded. The Contest will be considered official after Week 9 of the 2026-27 NFL football season. If the NFL season does not run at least nine (9) weeks, all Contest entry fees will be refunded. If the NFL season is not completed as scheduled, but lasts nine (9) weeks or more, all remaining entries will split the prize. If material technical difficulties or other Acts of God circumstances prevent the Contest from being completed after week 9, the Contest will still be action. a. If the NFL season is suspended (but not outright canceled), the Contest will be suspended until the season resumes. If 90 days pass with no NFL game being completed, the Contest will end, and entry fees will either be refunded (if before Week 9) or prizes will be awarded to remaining entries (if during or after the beginning of Week 10).
17. All SuperBook House Rules apply to this contest unless otherwise stipulated in these rules.
18. The SuperBook reserves the right to cancel this contest or refuse to accept any registration or wager if the same could violate any federal, state or county law, ordinance, or regulation. Furthermore, the SuperBook may cancel the contest in the event of technical difficulties or other occurrences beyond the control of the SuperBook.
19. Selections may be accepted manually over the counter in case of computer system failure, or other unforeseen circumstances as deemed necessary by SuperBook management.
20. Entry fees will not be refunded for reasons other than the cancellation of the SuperContest Survivor.
21. After the final winners are posted, a three (3) day verification period will occur. Any disputes with the contest and results or prize allocation must be provided to management in writing within this verification period. At the end of the three (3) day verification period, the SuperContest Survivor results will be declared official, and payout will be awarded on Friday, January 15, 2027.
22. In the event of a dispute, the decision of management is final.
23. Key employees, as well as family members of the SuperBook, may not participate or serve as a proxy in the SuperContest Survivor.
24. All contestants agree to grant the SuperBook unconditional use of their name and likeness for promotion as/advertising and announcements without compensation, consideration, notice review or consent.
25. All decisions regarding the interpretation of rules, eligibility, etc. for this promotion lie solely with The SuperBook whose decisions are final.
26. All contest times are approximate. SuperBook reserves, in full, all rights in enforcing any time deadlines and decision will be final.
27. All entries are subject to review and verification.
28. The SuperBook reserves the right to modify or cancel this contest at any time for any reason, subject to any applicable regulatory approval provided that such modification shall not, as the date of such modification, materially alter or change any participant's prize already awarded.
29. The SuperBook may disqualify any person for any prize based upon belief of the possible commission of fraud, dishonest, violation of contest rules or other misconduct, whether or not, related to this contest.
30. Record of entries will be retained for record keeping purposes in accordance with legal requirements.
31. Individuals who are excluded from casino facilities, including through a government program, at The Superbook discretion, or by their own request, are not eligible to participate or win any prize.
32. A copy of these rules and any changes will be available at the SuperBook throughout the duration of this contest.
33. All laws and regulations of the Nevada State Gaming Commission and Gaming Control Board apply.
